## CONSUMER VOICES HEARD

To document and understand patients' experiences when accessing their health information electronically, AHIMA Foundation conducted a qualitative survey of older adults and people with disabilities in August 2022 with Knowbility, a nonprofit organization whose mission is to create an inclusive digital world.



"Most sites, especially online health record systems, are not made in such a way that they're compatible with assistive technology. For me, this means that I cannot easily use a screen reader on my phone or computer to send messages to providers, review test results, interpret and pay bills, and refill medications."

"It takes me a while to type, and it would be great if there were no time limits when filling out forms and my basic information like name, email address, etc. can be automatically entered on health forms or somehow be made easier to enter."

All the documents and hospital records were provided to me in print, and I cannot see to access them. It would have been nice to have access and everything provided me everything in Braille."
